

TOWER TRANSIT NAMED INTERNATIONAL BUSINESS OF THE YEAR AT BRITISH EXPERTISE INTERNATIONAL AWARDS 2017

LONDON, 10 APRIL 2017 – The Tower Transit Group has been named 'International Business of the Year' at the British Expertise International Awards held at on 5 April 2017. This is the highest honour presented at the Awards and recognises the UK business "judged to have achieved the most impressive overall business performance internationally during 2015/16."

Judged by a distinguished panel which included HRH the Duke of Gloucester, the Department for International Trade's Head of Infrastructure Brian Gallagher and the World Bank's Senior External Affairs Counsellor to the UK and Ireland Andrew Felton, Tower Transit edged out finalists Arup and Turner & Townsend to clinch the award.

"It is a distinct honour for us to be in the company of two of the most renowned engineering and construction firms in the world. In contrast, Tower Transit started in 2013 as a small operator of public buses in London. What we've managed to achieve since then is hugely disproportionate to the size and brief history of the Tower Transit Group," said Tower Transit's Group CEO Adam Leishman.
